- 1. EXPLANATORY STATEMENT PURSUANT TO SECTION 102 (1) OF THE COMPANIES ACT, 2013

ITEM NO. 1 BORROWING POWERS OF THE COMPANY AND CREATION OF CHARGE / PROVIDING OF SECURITY.

Pursuant to the Board resolution passed on 29th November,2023 the Company seeks your approval for the credit facility availed and to be availed from Banks and Financial Institutions, up to a limit of INR 15 crores. The Company's borrowing aligns with the provisions of Section 180(1)(c) of the Companies Act, 2013.
